Dear Mr. Milam:

This acknowledges receipt of your affidavit and notice to our Department dated February 14, 1986, in which you voluntarily cancelled/surrendered your California driver's license and/or vehicle registration.

The driving upon California highways of a motor vehicle without a driver's license or the operation of an unregistered vehicle will subject you to citation, arrest and the seizure and sale of your vehicle(s) pursuant to one or more of the following statutes:

California Vehicle Code

4000(a)	Vehicles required to be registered
5202	Display of license plates required
12500(a)	Unlawful to drive motor vehicle unless licensed
12951(a)	Unlawful to drive motor vehicle with license not in
	possession
12951(b)	Refusal to present driver's license to peace officer

Revenue and Taxation Code

10751 Payment of registration fee required for operation of vehicle upon highways

Section 9800 of the Vehicle Code and Section 10876 of the Revenue and Taxation Code provide that fees due shall be a lien upon the vehicle. Under Vehicle Code Section 9801 and Revenue and Taxation Code 10877, the lien may be satisfied through the seizure and sale of the vehicle. Vehicle Code Section 9801 also requires the Department of Motor Vehicles to collect, in addition to the fees and penalties due, the costs for preparing to and/or seizing the involved vehicle. This additional cost could amount to as much as \$250.

The constitutional legality for the State of California to establish and enforce driver licensing and vehicle registration laws has been upheld by United States (federal) District Courts. To wit:

"...The police power of the state to promulgate a vehicle code with license and registration requirements cannot be questioned, and the applicability of the license and registration requirements of the California Vehicle Code to non-commercial users of the public highway is evident on the face of the statute." (See page 3, lines 3-9.)

United States District Court, Northern District of California Case #C 84-20461-RPA Michael W. Smith vs. Officer Ota, et al., November 14, 1984.

"...The complaints further allege the right to travel by vehicle has been inhibited, and, the Court finds that such travel by vehicle is a privilege and the restrictions imposed and complained (must have driver's license; vehicle must be registered) are a valid exercise of State police powers...." (See page 4, lines 17-21.)

United States District Court, Eastern District of California Case #CIV S-84-1000 RAR Irwin Koff, et al., In Pro Per vs. Darby Lanon, et al., February 27, 1985

In conclusion, your arguments that you have an inalienable right to operate a motor vehicle without a driver's license or registration of the vehicle are without merit. Should you feel that the State of California is without legal authority to require the possession of a driver's license and/or payment of registration fees, you may, of course, initiate whatever legal proceedings you deem appropriate.

Thank you for your letter, dated March 24, 1986, in which you responded to my Rescindment of Contracts and Revocation of Powers. I appreciate the time you spent, and your obvious sincerity. I would like to take this opportunity to make sure that you understand my position.

Your reference to case law to justify your position is commendable, since it indicates your desire to comply with constituted authority. However, case law is like statistics. That is, you can support any position you choose, by carefully selecting your cases. I could equally well support my position by citing cases. The exercise would accomplish nothing.

I have Rights not because of the Courts, not because of the various Constitutions, but because of the long tradition of the exercise of those Rights. This tradition predates the Municipal Courts, the California Vehicle Code, and our Constitutions. My Rights exist under the Common Law, before the sovereign People. With no personal malice toward you, I intend to continue the free exercise of my Rights. I will resist any attempt to restrict them, and will consider void any document or doctrine, including Public Policy and the Vehicle Code, which aids the restriction.
